Subj: DELEGATION OF AUTHORITY TO MAJOR SUBORDINATE COMMAND
COMMANDING GENERALS

Ref: (a) MCO 1001R.1L (MCRAMM)

1. Situation. In accordance with the reference, the Commander, Marine Forces Reserve or his designated representative will adjudicate certain requests or notifications.

2. Cancellation. Force Policy Letter 03-12.

3. Mission. In order to support the timely processing of specific requests or notifications, this policy letter delegates specific authorities to be adjudicated by the cognizant Major Subordinate Command (MSC).

4. Execution

a. In accordance with Chapter 5, Section 5, paragraph 1.a(1) of the reference, MSC Commanding Generals (CG) are delegated the authority to manage and track notifications from Selected Marine Corps Reserve (SMCR) Unit Marines that are executing travel outside of the United States for 60 days or less.

b. In accordance with Chapter 5, Section 5, paragraph 1.a.(2) of the reference, MSC CGs are delegated the authority to manage and track notifications from SMCR Unit Marines who fly aircraft of commercial airlines of the United States that are executing travel outside of the United States for periods in excess of 21 days.

c. In accordance with Chapter 7, Section 2, paragraph 10.d(2) of the reference, MSC CGs are delegated the authority to adjudicate requests for a split Annual Training period.


d. In accordance with Chapter 4, Section 4, paragraph 7.a. of the reference, the CG, 4th Marine Aircraft Wing (MAW) is

delegated the authority to make Duty in a flying status involving operational flights (DIFOP)/Duty in a flying status, flight activity denied (DIFDEN) assignments within 4th MAW.

e. In accordance with Chapter 4, Section 4, paragraph 6.b(3)(a), of the reference, the CG, Force Headquarters Group is delegated the authority to assign Deputy District Commanders (Peacetime Wartime Support Team) and Mobilization Training Unit Officers in Charge.
