FORCE POLICY LETTER 5-06

Subj: MOTORCYCLE/ALL TERRAIN VEHICLE (ATV) INDIVIDUAL AGREEMENT

Encl: (1) Motorcycle/ATV Individual Agreement

1. There has been a marked increase in the number of mishaps involving motorcycles and ATVs. Due to these circumstances, the Motorcycle/ATV Individual Agreement contained in the enclosure will be utilized by all Marine Forces Reserve (MARFORRES) Units. The individual agreement will ensure that motorcycle/ATV riders understand the Personal Protective Equipment (PPE) and licensing requirements to ride a motorcycle or ATV. Additionally, Marines will understand that they will be held personally accountable for acting in a manner that is not acceptable in the line of duty.

2. The following actions will be taken:

a. MARFORRES Safety. Ensure that any necessary clarification of intent is resolved relating to the Motorcycle/ATV Individual Agreement.

b. Major Subordinate Command Safety. Ensure that the Motorcycle/ATV Individual Agreement is distributed to all subordinate units and implemented.

c. MARFORRES Units

(1) Ensure that all motorcycle/ATV riders read and sign the Motorcycle/ATV Individual Agreement.

(2) Complete a Service Record Book/Officer Qualification Record Page 11 entry as follows: "I, (Marines name) have read, understand, and will comply with the MARFORRES Individual Agreement Information Brief for motorcycle/ATV operation pursuant to the policies and requirements contained in the current edition of MCO 5100.19."


(3) Maintain a copy of the completed Individual Agreement in the Unit Safety Department.

I, _____, have read and understand the requirement of safe motorcycle/ATV

operations per the current edition of MCC 5100.19. I acknowledge the Marine Corps requirement for Personal Protective Equipment (PPE), licensing requirements and MSF training requirements and responsibilities agreement. I understand that if I am injured while riding a motorcycle/ATV in violation of this policy, I may be found 100% in-line of Duty due to my own misconduct. Such a finding by an investigating officer can result in my loss of benefits, to include my right to free medical care, my right to disability pay, or separation pay, or medical retirement from the service if my injuries make me no longer eligible for military service. I could also face forfeiture of many of my veteran's rights such as education benefits. In addition to the Marine Corps requirement for PPE, I acknowledge that my commander has given me a direct order to WEY/HR operate a motorcycle/ATV without the PPE, and without first meeting the requirements for licensing and safety training as outlined in this agreement. My failure to comply with his/her order is punishable under Article 92 of the Uniform Code of Military Justice.
