

TRICARE RESERVE SELECT

It's all about

BEING READY


READY, RELEVANT AND RESPONSIVE...

Reserve Marines and Sailors have to be combat ready at all times. To maintain medical readiness and optimal health, Reserve Marines and Sailors are encouraged to maintain continuous health and dental coverage, whether through TRICARE or other coverage for which they may be eligible. TRICARE Reserve Select is a premium-based plan available worldwide for qualified Reservists and their families.



COST

- Monthly premiums, annual deductibles and cost-shares apply.
- Sponsor only: **\$51.68/month**
- Sponsor and family: **\$204.29/month**



ELIGIBILITY

- You are eligible if you are in the Selected Marine Corps Reserve or Individual Mobilization Augmentee program.
- Individual Ready Reserve Marines, Marines who have completed orders in the last 180 days and Marines eligible for the Federal Healthcare Benefit Program are ineligible.



ACTIVE BENEFITS

- You will receive active-duty benefits if...
- you are on orders for 30 days or more.
- it is 180 days before/after you go on orders for 30 days or more.

- Emergency care
- Outpatient visits
- Preventive care
- Hospitalization
- Maternity care
- Mental health
- Prescriptions

TRICARE DENTAL

While you are in an inactive status, you and your family can enroll in the TRICARE Dental Program. You can enroll any time and must enroll for at least 12 months.

If you receive orders to activate for more than 30 days, your enrollment will change. But your family's enrollment in the program will continue.

While IRR Marines are not eligible to enroll in TRICARE Reserve Select, they are eligible for TRICARE dental.
